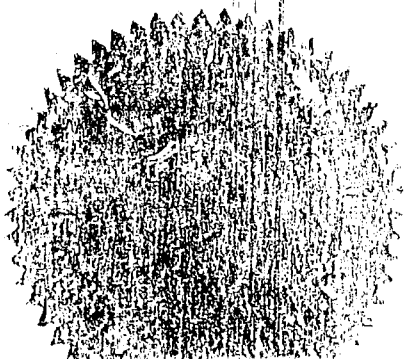

ARTICLES OF INCORPORATION  
OF  
THE PHILIPPINE SOCIETY OF BIOCHEMISTRY AND MOLECULAR  
BIOLOGY, INC.  
formerly; The Philippine Biochemical Society, Inc.

KNOW ALL MEN BY THESE PRESENT:

That we, the undersigned, all of whom are of legal age, citizens and resident of the Philippines, have this day voluntarily associated ourselves together for the purpose of forming a private, non-stock corporation under the laws of the Republic of the Philippines.

AND WE HEREBY CERTIFY:

FIRST: That the name of the corporation shall be "The Philippine Society of Biochemistry and Molecular Biology, Inc. \*

SECOND: That the purposes for which such corporation is formed are as follows:

1. To promote the advancement of knowledge in Biochemistry;
2. To encourage research and education in Biochemistry;
3. To encourage the continuing education of teachers of Biochemistry;
4. To establish channels of communication and interchange of professional knowledge among members as well as with other biochemists abroad;
5. To foster mutual understanding and harmonious relationship among members of the Society;
6. To do other acts and things necessary to to carry out these purposes in accordance with the ideals of good citizenship and nationalism in compliance with the existing laws of the Republic of the Philippines.

This Society shall be non-partisan, non-sectarian, and non-sectional, and any question involving the political status of the Republic of the Philippines or the form of government and its administration is absolutely prohibited at any meeting of the members of the corporation or its Directors.

THIRD: That the place of the principal office of the Society is to be established or located in Manila, Philippines.

Fourth: That the term for which the said corporation is to exist shall be
